Non-Compete and Non-Solicitation Agreement

You also agree not to encourage or induce any such person to leave or breach their relationship with the Company.

5 Non-Solicitation of Clients/Customers

For one (1) year after your employment ends, you shall not directly or indirectly

disclose any information regarding the Company's clients or customers, including names or contact details. You further agree not to contact, solicit, or attempt to solicit any customer or client whom you had contact with or became aware of during your employment.

6. Injunctive Relief

You acknowledge that any violation of this Agreement would cause irreparable harm to the Company, for which monetary damages alone would be insufficient. Therefore, the Company shall be entitled to seek injunctive relief in addition to other legal or equitable remedies to enforce the terms of this Agreement.

7. Severability

If any provision of this Agreement is found to be invalid or unenforceable, in whole or in part, the remaining provisions shall remain in full force and effect to the maximum extent permissible by law.

8. Modifications

Any changes to this Agreement must be made in writing and signed by both you and an authorized representative of the Company.

9. Entire Agreement

This document constitutes the full and complete understanding between you and the Company regarding the subject matter herein and supersedes all prior discussions, agreements, or representations.

10. Waiver

Signed and agreed on.

Any waiver of a breach under this Agreement must be in writing. A waiver of one provision or breach does not constitute a waiver of any other provision or future breach.

11. Governing Law and Jurisdiction
